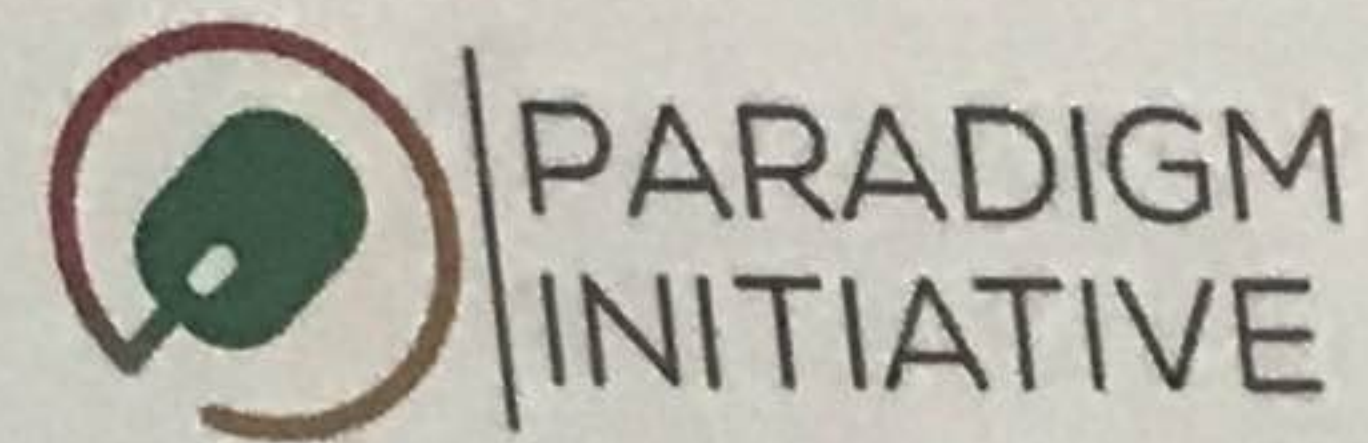
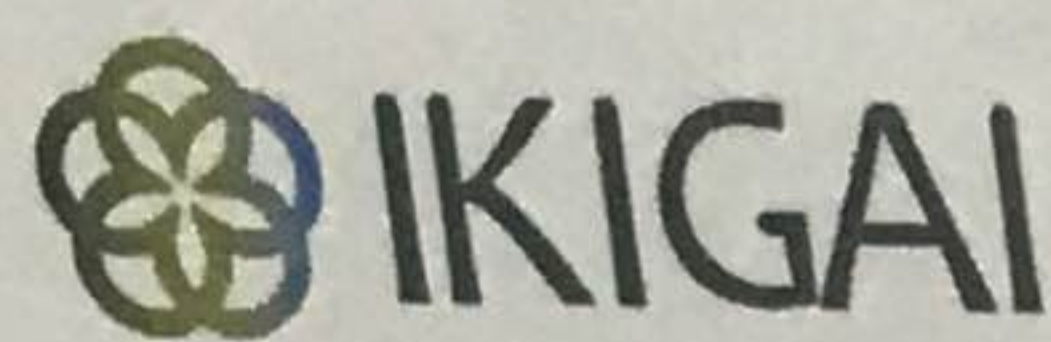

Pursuant to Section 1(1) and Section 4 of the Freedom of Information Act, 2011, Paradigm Initiative and Ikigai Innovation Initiative requests the assistance of your office with the following information with regards to the recent news report that security agencies can now access subscribers' database with the National Identity Management Commission (NIMC) through the Nigerian Communications Commission. The said statement was credited to the Minister of Communications and Digital Economy and was reported by Punch newspapers and other mainstream media outlets in Nigeria between February 4 to February 7 2022.

1. What legal provisions were relied on to give such access to security agencies?
2. What legal provision gives the President of the Federal Republic of Nigeria the power to give such access to security agencies?
3. What legal provision gives the Minister of Communications and Digital Economy the power to give such access to security agencies?
4. To what extent might this be in contravention to the rights to privacy guaranteed in the 1999 constitution of the Federal Republic of Nigeria as amended and the procedure for accessing subscribers data?
5. What are the legal and institutional safeguards in place to ensure accountability on the part of the security agencies who have been given access?
6. Is there any judicial or independent oversight around the working relationship between the NCC, NIMC and security agencies in Nigeria
